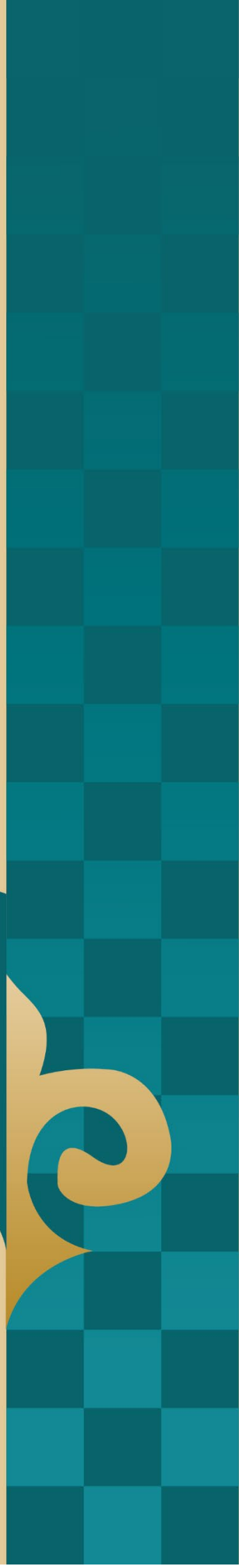

REGULATIONS

Vladimir Dvorkovich Memorial — Aktobe Open 2026 International Chess Tournament
(Stage 1 of the Kazakhstan Chess Cup 2026)

1. General Provisions

1.1. The Vladimir Dvorkovich Memorial — Aktobe Open 2026 International Chess Tournament (hereinafter the "Tournament") is conducted in accordance with the calendar of sporting events organized by the Kazakhstan Chess Federation (KCF) for the following purposes:

- to honor the memory of International Arbiter Vladimir Yakovlevich Dvorkovich;
- to popularize chess in the Republic of Kazakhstan and the Aktobe Region;
- to develop professional chess in the Republic of Kazakhstan;
- to enhance the skills of the RK national adult and youth teams;
- to determine candidates for participation in the Kazakhstan Chess Cup 2026 Final.

2. Organizing Committee

2.1. The overall management and organization of the Tournament shall be carried out by the Kazakhstan Chess Federation (KCF) with the support of the Ministry of Tourism and Sports of the Republic of Kazakhstan as well as the Department of Physical Education and Sport of Aktobe Region

2.2. The direct execution and management of the tournaments shall be the responsibility of the Tournament Directors and the Arbiter Panels approved by the KCF Presidium.

3. Dates and Venue

3.1. Dates: June 2 (arrival day) – June 12 (departure day), 2026;

3.2. Playing venue: will be published on the KCF website.

4. Tournaments and Conditions

4.1. The Stage consists of two tournaments (hereinafter the Tournaments):

- **Masters** tournament;
- **Open** tournament.

4.2. The Tournaments shall be FIDE rated.

4.3. The Tournaments shall be held as 9-round Swiss system events in accordance with FIDE Laws of Chess.

4.4. Pairings shall be made using the Swiss Manager software.

4.5. Time control: classical 90+30 (90 minutes for the entire game with an increment of 30 seconds per move starting from move one).

4.6. Any player arriving at the chessboard more than 30 minutes after the start of the session shall lose the game by default.

4.7. Draw offers are prohibited before move 30.

4.8. Fair play (anti-cheating) measures shall be implemented in accordance with the FIDE Anti-Cheating Regulations under the standard protection level. A 15-minute broadcast delay shall be applied.

4.9. All players must adhere to the dress code (Business Casual, Smart Casual; shorts and slippers are not allowed).

4.10. Smoking in the playing hall is prohibited.

4.11. A player who has finished their game is considered a spectator and must leave the tournament hall.

4.12. The Masters Tournament is included in the FIDE Circuit series and is taken into account for point calculation in accordance with the current FIDE Circuit Regulations.

5. Appeals

5.1. To resolve disputes, an Appeals Committee (AC) shall be elected at the Technical Meeting of each stage, consisting of a Chairperson, 2 main members, and 2 reserve members.

5.2. A player may appeal any decision of the Arbiter Panel by submitting a written appeal to the AC within 1 hour after the end of the round and paying an appeal fee of KZT100,000;

5.3. The decision of the Appeals Committee is final.

5.4. In the event an appeal is upheld, the appeal fee shall be refunded in full.

7. Participants and Entry Fees

7.1. The maximum number of participants is 300 players. Priority of participation is given to athletes based on their application date (earlier applications are prioritized).

7.2. The following players are eligible to participate, provided they meet the requirements below as of 1st April 2026:

By decision of the Coaching Council of the Kazakhstan Chess Federation, additional participants may be admitted.

7.3. A 50% discount on the entry fee for the Open tournament is available to the following citizens of the Republic of Kazakhstan: juniors (born in 2008 and later), seniors (born in 1966 and earlier), and participants with disabilities (Categories 1, 2, and 3).

7.4. The entry fee is non-refundable in the event of withdrawal or if the application does not meet the rating requirements.

7.5. The Organizing Committee provides hospitality only to invited athletes who meet the requirements below (the final list of invited participants is formed by the **Republican Public Association "Kazakhstan Chess Federation"**):

- *Hospitality applications must be sent to tournaments@kazchess.kz;*
- *The organizer accepts a limited number of hospitality applications;*
- *The Organizing Committee reserves the right to refuse hospitality due to the limited number of available places;*
- *An upgrade of a twin room to a single room is possible upon additional payment;*
- *Hospitality is provided to no more than two athletes from the same country;*
- *Submission of an application does not guarantee automatic hospitality;*
- ***The final list of invited athletes is formed by the Kazakhstan Chess Federation in coordination with the Kazakhstan Chess Federation Coaches' Council.***

8. Registration and Applications

8.1. Registration for the tournaments is accepted at the following link: <https://opencups.kazchess.kz> until May 2, 2026;

8.2. The Organizing Committee reserves the right to close registration before the specified date once the maximum number of participants is reached;

8.3. The Organizing Committee reserves the right to refuse registration after May 2, 2026;

8.4. For participants requesting registration after May 2, 2026, the entry fee will be increased by KZT 75,000 ≈ USD 150;

8.5. Entry fees are accepted during the tournament registration process on the KCF website <https://opencups.kazchess.kz>;

8.6. In the event of withdrawal from the tournament or if an application does not meet the rating requirements, the entry fee is non-refundable;

8.7. Personal presence at the accreditation is mandatory; in case of absence without prior notice sent via email to tournaments@kazchess.kz before the end of the accreditation period, the Organizing Committee reserves the right not to include the participant in the first-round pairings.

9. Visa

9.1. An invitation reference number is required to apply for the visa. The processing time for the authorized body to issue an invitation number is at least 2 weeks; therefore, participants must submit the requested documents no later than one month before the start of the tournament.

9.2. Fees for the issuance of an invitation reference number:

9.2.1. Accompanying persons and participants shall pay 20 USD to the Organizing Committee for the issuance of the invitation number.

9.2.2. For invited participants who are provided with hospitality, the cost of issuing the invitation number shall be covered by the organizers.

9.3. Upon receiving the unique invitation reference number, participants shall independently apply for an electronic visa (e-visa) on the website: <https://www.vmp.gov.kz/ru/services/visa-service>.

9.4. The electronic visa must be printed for presentation during border crossing and while staying within the territory of the Republic of Kazakhstan. The electronic visa grants the right to enter and exit the Republic of Kazakhstan only **through international airports**.

9.5. Participants may also obtain a visa sticker at the Embassy of the Republic of Kazakhstan.

9.6. The visa fee is 80 USD.

*Note: For invited participants who are provided with hospitality, the visa fee shall be covered by the organizers.

10. Determination of Winners. Awarding

10.1. Winners of the competitions are determined by the highest total number of points scored in all games. In case of a tie, the following criteria shall apply in order:

- a) Buchholz Cut 1 (excluding the lowest result);
- b) Direct encounter (provided that all participants in the tie played against each other);
- c) Greater number of wins;
- d) Performance rating.

10.2. Guaranteed Prize Fund of the Tournament. ***The prize fund is calculated in KZT; the amount in USD is indicated based on the exchange rate of the National Bank of the Republic of Kazakhstan at the time of signing the regulations.**

10.3. Taxes will be withheld from all prizes in accordance with the current legislation of the Republic of Kazakhstan;

10.4. Main and special prizes are not shared;

10.5. A participant may receive only one prize, the highest one;

10.6. **The tournament prize fund is calculated in KZT. The amount in USD is provided for informational purposes only and is converted at the exchange rate of the National Bank of the Republic of Kazakhstan at the time of signing the regulations. Prize payouts are made in KZT, USD, or EUR; the conversion is performed at the exchange rate of the National Bank of the Republic of Kazakhstan on the date of payment;**

10.7. The deadline for submitting documents for prize payouts is seven (7) calendar days. The prize payout period is up to thirty (30) working days from the moment all necessary, properly executed, and signed documents are received;

10.8. If a player does not have a bank account, if it is blocked, or if a transfer to their bank account is impossible due to sanctions or other circumstances, the player must, among other things, provide a notarized power of attorney for a third party to receive their cash prizes;

10.9. Cash prizes are not paid in physical cash, and if the player fails to provide the requested documents within seven (7) calendar days from the end of the tournament, the Organizing Committee reserves the right not to pay the prize.

11. Competition Expenses

11.1. **The Kazakhstan Chess Federation (KCF) shall bear the following expenses for the competition:**

- Provision of the prize fund in the amount of **KZT 45,000,000 for the Masters Tournament;**
- Provision of the prize fund in the amount of **KZT 5,000,000 for the Open Tournament;**
- Payment for the Arbiter Panel;
- Partial payment of organizational expenses.

11.2. **The Department of Physical Education and Sport of Aktobe Region shall provide:**

- Administrative and logistical resources (200 tables, 300 chairs);
- Organization of the Opening and Closing ceremonies;
- Musical accompaniment for the Opening and Closing ceremonies;
- Medical support during the tournament;
- Public order and security during the championship;
- Fire brigade standby during the tournament;
- Provision of the tournament hall venue;

- Event branding and decoration;
- Transport expenses: meeting Grandmasters at the airport and providing transfers to the location.

11.3. Expenses related to travel and accommodation for participants shall be borne by the **sending organizations**.

12. Rights and Obligations of Participants and Accompanying Persons

12.1. Participants shall play in accordance with the FIDE Laws of Chess and these Regulations.

12.2. Recording of games (scorekeeping) is mandatory for all participants, except for those in the "Under 6" category.

12.3. A participant who fails to record the game after two warnings from the arbiter shall be declared lost. If the situation recurs in a subsequent game, the participant shall be disqualified from the competition.

12.4. Participants, coaches, and accompanying persons shall comply with the code of conduct and rules of decency in public places as established by the legislation of the Republic of Kazakhstan.

12.5. In the event of systematic violation of playing discipline, intentional provocation of scandalous situations, or other violations, the participant shall be disqualified from the competition. In the event of similar violations by coaches or accompanying persons, the violators shall be deprived of the right to remain at the Cup.

12.6. Cup participants shall be entitled:

- to appeal to the Appeals Committee (see Clause 5.2);
- to receive primary medical assistance in the tournament hall.

12.7. In accordance with Article 145 of the Civil Code of the Republic of Kazakhstan and taking into account the requirements of Paragraph 8 of Article 15 of the Civil Code of the Republic of Kazakhstan, for the purpose of promoting the sporting events of the Kazakhstan Chess Federation and the activities of the Organizer, the Participant gives the Organizer their consent:

- For the Organizer and/or third parties acting on behalf of and/or in the interest of the Organizer to perform video and photography of the Participant's image (photo and/or video) during the course of their participation in the Competition;
- For the Organizer to use the Participant's name, and to publish, reproduce, and distribute the Participant's image and/or other audio, video, or photographic materials obtained as a result of the Competition featuring the Participant, by any means and in any media without limitation on time or territory, including the right to edit said materials and transfer them to third parties.

The Participant provides this consent on a free-of-charge basis for an indefinite period and shall not be entitled to claim any form of compensation from the Organizer in the future.
